## Other Terms and Conditions

- (i) Candidates must be a Citizen of India.
- (ii) Age Relaxation: Relaxation in age limit is available as per rules (05 Yrs for SC/ST, 03 Yrs for OBC, 10 Yrs for physically handicapped and as per DOPT instruction for candidates granted status of Ex-Servicemen)
- (iii) The positions are PERMANENT and NON TRANSFERABLE.
- (iv) Probation: The selected candidates will be on compulsory probation for a period of two years, before being considered for confirmation. The probation period may be extended further at the discretion of competent authority.
